PURPOSE

This Request for Quotation (RFQ) will result in the selection of the most qualified and cost effective subcontractor to provide electrical panel upgrades for solar photovoltaic systems and support services to Spectrum Community Services, Inc. Demonstrated electrical contractor ability to achieve high customer satisfaction results, warranty support, and superior electrical for solar system performance will be important factors in the selection process.

I. SCOPE OF PROGRAM SERVICES

Spectrum Community Services, Inc. Energy Program is scheduled to install solar photovoltaic systems on approximately 5 single family residential homes in various locations throughout Alameda County California. These solar system installations will be completed over a six month process period ending in September 2020. The electrical contractor will supply, and install electrical upgrades to the panels for the solar systems to various locations throughout Alameda County, and therefore will need the capacity to support the five dwellings needing the electrical upgrades to the panels to the solar installations for this contract. The electrical subcontractor will pull all permits needed to upgrade the electrical panel. The subcontractor selected will be required to provide follow-up services in the event the customer or SCS or its subcontractor initiates a warranty claim.

II. FEE SCHEDULE FOR SCOPE OF SERVICES

A fixed fee per watt including warranty services is being requested and the price provided will be guaranteed for six (6) months.

All responses must include the following items and this information will be used to select the most qualified cost effective vendor. Please package your RFQ in the following order:

1. Narrative outlining:
 - a. Company background information including years in electrical industry
 - b. Business model detailing internal operations relating to how orders are placed, shipping process including lead time to receive orders submitted, invoicing system, payment terms and how warranty issues are handled and resolved.
 - c. Customer Service – Please provide an overview of how your company handles return of defective parts, customer service issues or inquiries.
2. Please provide three (3) references and contact information
3. Completed contractor Cost Proposal.

4. Copy of Contractor License

Responses should be concise and include the information requested within this RFQ. Generic promotional or product information materials are not required however can be provided.

A submittal will be deemed unresponsive if the information requested is not provided or if the RFQ and supporting requested documentation is submitted late.
