



Need Help with Energy Bills?

What the program offers:

PG&E and Alameda Municipal Power bill assistance for a one time payment per program year.

Applicants must:

- ◆ Live in Alameda County.
- ◆ Provide a complete PG&E or Alameda Municipal Power bill. Provide proof of monthly income for the entire household, which is not to exceed the amounts indicated on the 2023 LIHEAP Gross Income Guidelines.

LIHEAP is a federally-funded program to help low-income households pay their energy bills. Assistance is in the form of a direct payment to the utility company on behalf of an eligible applicant. Eligibility is based on the household's total monthly income, which cannot exceed the LIHEAP income guidelines below.

Federal LIHEAP funds are for households with low incomes and high energy costs, prioritizing households with elderly, disabled persons and/or children under six years old.

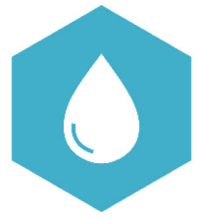

Get help paying your household water bill

To qualify, you must:

- ❖ ...live in Alameda County
- ❖ ...fall under the household monthly gross income guidelines below
- ❖ ...be able to show government-issued ID

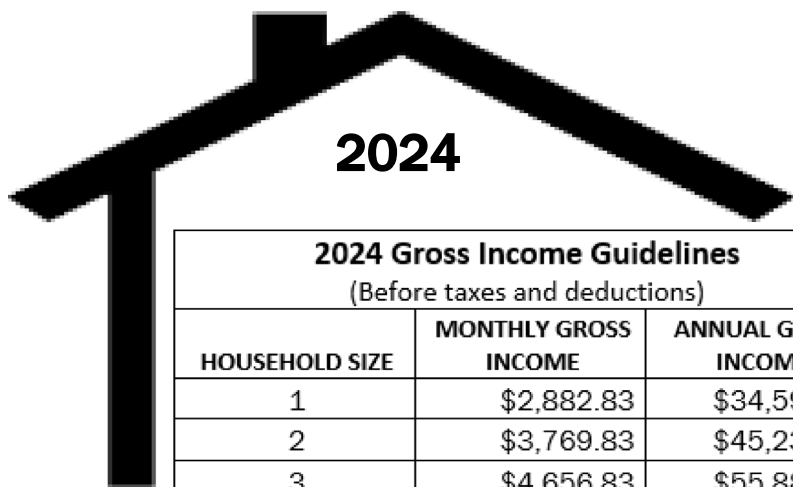

- Specify if you are requesting LIHWAP assistance alone, or LIHEAP and LIHWAP combined
- Specify the name of your water or wastewater agency

LIHWAP is a temporary, federally-funded, COVID-relief program to help low-income households with a one-time payment on their water or sewage bill. Assistance is in the form of a direct payment to the participating water or wastewater service. The program expires March 31, 2024.

Program overview:

- LIHWAP can assist with only water or sewage bill, not both, unless they appear on the same bill
- Customers of Castro Valley Sanitary District and Dublin San Ramon Service District must be past due to be eligible. All others can be current or past due.
- Applicants can apply simultaneously to LIHWAP and the Low Income Home Energy Assistance Program (LIHEAP)
- Priority is given to those facing discontinuation of services
